Seacliff State Beach is one of the most popular premium beachfront spots offering only RV camping (no tents); numerous picnic areas with barbecue grills; group picnic area (ramada); beach and upper day-use parking lots; a visitor center (museum); nearly one mile of shoreline and the historical concrete ship "Palo Alto." There are 26 sites with full hookups in the campground and 2 overflow lots (Lots B and C) with no hookups.

CAMPGROUND RULES AND REGULATIONS

1. Check-in time is 2:00 PM. RV unit must be physically present to register for camping.
2. Only one fully self-contained RV (motor homes/trailers) and a maximum of eight persons allowed per campsite. No two trailers, motor homes, or a combination of a motor home and trailer may camp at the same time in a single campsite. Awnings and bumpers must not extend over the walkway. Trailers are required to use blocks.
3. Fees include entry for one vehicle and one legally towed vehicle/trailer. Additional vehicles not towed in will be charged an extra vehicle fee. Extra vehicle parking is available in Lot C. Vehicle camping tags are not transferable.
4. Campers registering with discounted rates (i.e. Disabled Discount, Distinguished Veteran) must check-in with the discount card and picture ID, or they will have to pay the difference of regular camping fees.
5. Generators may be operated from 10:00 AM until 8:00 PM only.
6. Dogs must be on leash at all times and may not be left unattended at any time. Please keep dogs in an enclosed vehicle at night. Owners need to pick up after pets.

7. Fires or barbecues are not permitted on the beach.
8. No effluence or water may be discharged onto the ground. Do not wash vehicles or hose down campsite.
9. Check out time is 12:00 PM (noon). When checking out early, camper(s) must inform Camp host/Park Staff or forfeit refund of unused credits.
10. Camper(s) must vacate the campground for a period of 48 hours once the maximum consecutive night limit has been reached. No same vehicle and or equipment may re-register under different names to circumvent maximum stay limits.

HOOKUP CAMPSITES

Maximum RV length is 40 feet. Maximum stay of camper(s) in the park is seven nights (overflow and hookups combined). All RVs and trailers must back in. Only one tent is permitted in each RV campsite.

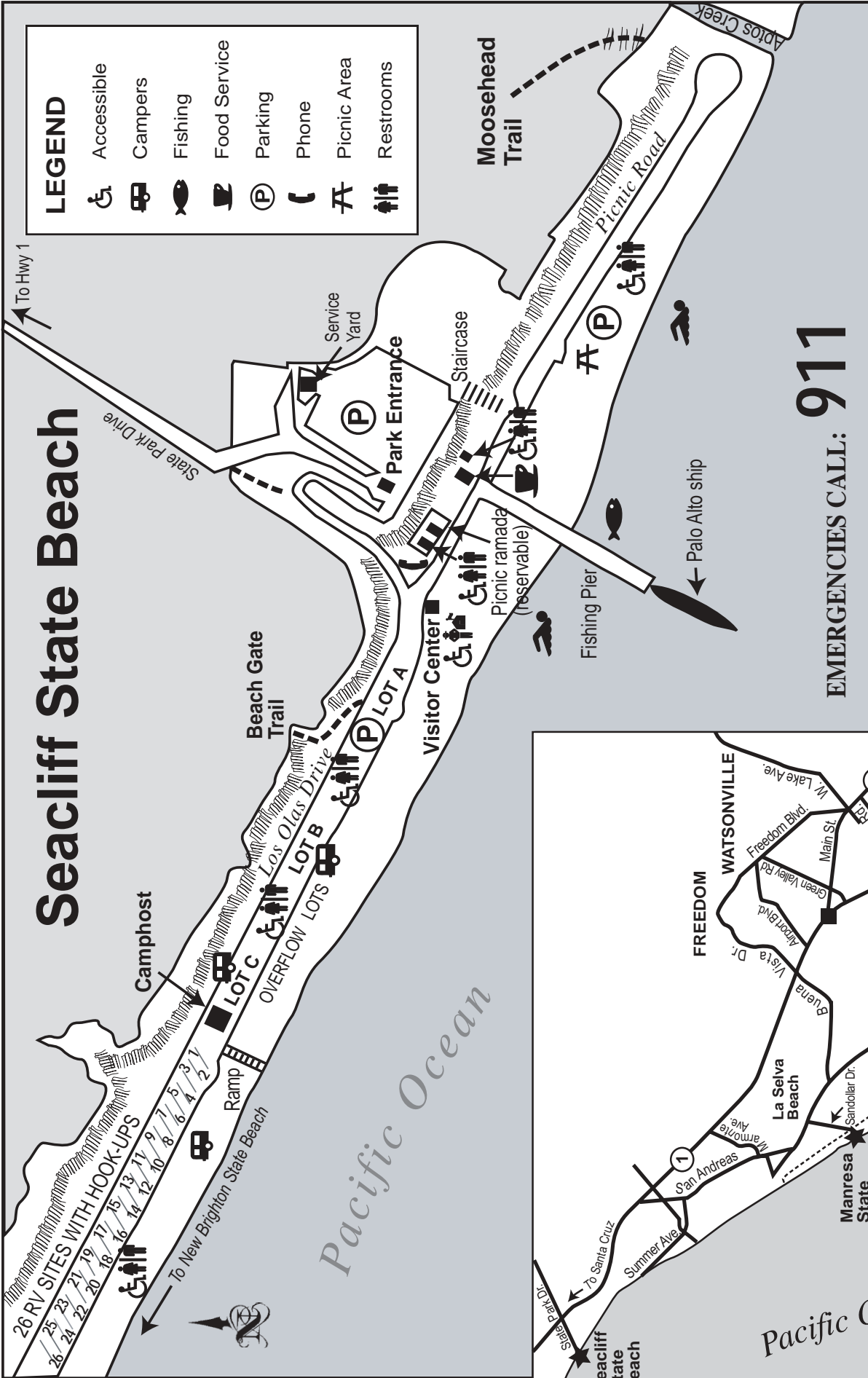
OVERFLOW CAMPSITES

Only fully self-contained vehicles (sealed effluence tank, running water and flushable toilets) are allowed. Maximum RV length is 34 feet. No tents. Campers must sleep in their RVs. No prepayments are accepted. RV/trailer must be present to register.
